MENTERI KEUANGAN,

MEMUTUSKAN :

Menetapkan : PERATURAN MENTERI KEUANGAN TENTANG PERUBAHAN

KESEMBILAN ATAS KEPUTUSAN MENTERI KEUANGAN NOMOR 89/KMK.04/ 2002 TENTANG TATA CARA PEMBERIAN PEMBEBASAN BEA MASUK DAN CUKAI ATAS IMPOR BARANG UNTUK KEPERLUAN BADAN INTERNASIONAL BESERTA PARA PEJABATNYA YANG BERTUGAS DI INDONESIA.

Pasal I
